

# 2003 SABEW DISTINGUISHED ACHIEVEMENT AWARD WINNERS



### James K. Gentry

Gentry is dean and professor at the William Allen White School of Journalism and Mass Communications at the University of Kansas. He was previously dean of the School of Journalism at the University of Nevada, Reno and a faculty member at the School of Journalism at the University of Missouri for 14 years. The School of Journalism at the University of Kansas has been praised by Quill magazine and is "considered by many to be the model for innovative curriculum revision". In its 1999 accreditation, the School was praised for its "pioneering curricular efforts to prepare students for media convergence". In addition, Gentry has presented workshops to hundreds of business reporters and is active in consulting in convergence, helping newspapers and broadcast operations develop partnerships in the areas of content, advertising, promotions, online and community outreach.



#### Randall D. Smith

Smith is an assistant managing editor at The Kansas City Star, and oversees metropolitan and state coverage while supervising a staff of 60 editors and writers. In his 26 year tenure with The Star, Smith has served in many capacities, including day city editor, business editor and recruitment for the newsroom. He also coordinates several newspaper internship programs, including the 25-year old Knight Ridder rotating program for minority journalists. Smith has led dozens of projects at The Star, and was a member of the team that won the 1981 Pulitzer Prize for spot news coverage of the Hyatt Skywalk collapse in Kansas City. He is a past president of SABEW and was heavily involved in the effort to raise \$1.1 million for the SABEW chair of business journalism.





# CONFERENCE SPEAKERS

#### Martin Baron

Baron was named Editor of The Boston Globe effective July 30, 2001. Baron previously was executive editor of the Miami Herald. Under his leadership, the newspaper won the Pulitzer Prize for break-



ing news coverage in 2001. In addition, he was named "Editor of the Year" by Editor & Publisher Magazine in April of 2001. Baron began his journalism career at the Herald in 1976, serving as a state reporter and later as a business writer. He moved to the Los Angeles Times in 1979. He became business editor in 1983, assistant managing editor for "column one," polls and special projects in 1991, and the editor of the newspaper's Orange County Edition in 1993. Baron then moved to The New York Times in 1996, and in 1997 became associate managing editor responsible for the nighttime news operations of the newspaper. He departed in 1999 to assume his post as executive editor of the Herald.

#### Ken Bertsch

Bertsch, appointed Vice President and Director, Corporate Governance for Moody's Investors Service in October 2002, is charged with developing greater analytical focus to issues of corporate governance in Moody's corporate credit analysis. Previously, he was Director, Corporate Governance, for Teachers Insurance and Annuity Association/ College Retirement Equities Fund (TIAA-CREF), a leading financial services organization, major institutional investor, and the world's largest private retirement system. He coordinated TIAA-CREF's Corporate Assessment Program during his tenure there, from January 1999 to October 2002, reviewing governance structures and practices of portfolio companies, and discussing concerns with selected companies. Bertsch previously worked in a variety of capacities for the Investor Responsibility Research Center for more than 14 years. IRRC is an independent research group that provides impartial analysis to institutional investors, corporations and others.

### Becky Bisbee

Bisbee joined The Seattle Times as business editor in August 2000. Previously, she was the business editor at The Austin American-Statesman and The Modesto Bee.

Bollinger is business editor of The Press Democrat's overseeing the newspaper's coverage of business, the economy and technology. The business editor for The Press Democrat since 1990,



he also writes a column on Sunday. The business section has won several national, state and regional awards for its coverage, including three "Best in Business" citations from SABEW. It has won the top award from the Society in 2002, 1999 and 1996 and won for spot news coverage in 2000.

#### Kate Lee Butler

Butler is senior business team leader at The Orange County Register. She joined the paper five years ago and is responsible for the business coverage in the paper and a 25-person staff. Before joining the Register, Butler



was business editor at the San Diego Union-Tribune. She's also been senior editor at Bloomberg News in London and has been a reporter and editor at papers in Massachusetts and Connecticut, including the Worcester Telegram & Gazette and the New Haven Register. She is a graduate of Wellesley College. where she studied economics.

#### Byron E. Calame

Calame is a deputy managing editor of The Wall Street Journal, where his responsibilities include the final reading of the paper's Page One and taking charge of the Journal in the absence of the managing editor. He joined the



Journal in September 1965 as a reporter in the New York bureau, and has also worked in the Los Angeles, Washington and Pittsburgh bureaus. Calame was president of SABEW in 2000-2001 and has also served as Vice President. He received the SABEW's Distinguished Achievement Award for 2002.

#### Darrell Christian


Christian was named business editor of The Associated Press in January 2000. Christian previously served for 1 1/2 years as director of AP MegaSports, an electronic sports service offering



stories, photos, audio, statistics and realtime scores. He was AP's managing editor from 1992 to 1998 and was sports editor for seven years prior to that. He was a Pulitzer Prize juror in 1995 and 1996. A native of Henderson, Ky., Christian attended the University of Kentucky. He joined the AP in Charleston, W.Va., and moved to Indianapolis in 1972. He became news editor there in 1975 and moved to the Washington bureau as a supervising editor in 1980. In 1981, he was named deputy sports editor in New York before being promoted to sports editor four years later.

### George David

David is chairman and chief executive officer of United Technologies Corporation. He was elected chief executive officer in 1994 and chairman in 1997. He has also served as the Corporation's president since January 2002, and pre-



viously held that position from 1992 to 1999. David is a member of the Board of Directors of Citigroup Inc. and the Board of Trustees of The Carnegie Hall Corporation, Inc. He is also a board member of the Institute for International Economics and the National Academy Foundation, and a member of The Business Council and The Business Roundtable.

#### Bill Dedman

Dedman is a consultant for The Boston Globe, where he writes investigative articles, and assists other reporters and editors, and trains the news staff



on computer-assisted reporting. He has led Power Reporting seminars on reporting and editing in more than 100 newsrooms, and his Power Reporting Web site is used by many journalists as a starting point for research. He also teaches at Boston University. Dedman began in journalism at age 16 as a copy boy and has been a staff writer for the Warrensburg (Mo) Star-Journal, The Chattanooga Free Press, The Chattanooga Times, The Knoxville News-Sentinel and The Washington Post, and an assistant metro editor for The Chicago Sun-Times.

#### Gail DeGeorge

DeGeorge has been the business editor of the South Florida Sun-Sentinel since 1998, and has been a South Florida-based business journalist for 20 years, working for regional and national publications. As a reporter,



she covered a broad range of stories, from the bankruptcy of Eastern Air Lines to the savings and loan crisis; white collar crime to the nascent capitalistic endeavors in Cuba. In her current post she directs coverage of South Florida's business community. She is the author of The Making of a Blockbuster: How H. Wayne Huizenga Built a Sports and Entertainment Empire from Trash, Grit and Videotape, published in 1996.

#### Karen Dillon

Dillon joined Harvard Business Review in 2003 as deputy editor, after spending five and a half years as deputy editor of Inc. magazine. During her time at *Inc.* she oversaw



the day-to-day running of the magazine and its 37person editorial staff. Prior to joining the monthly magazine for entrepreneurs, she was editor and publisher of The American Lawyer. During her tenure at the legal monthly, it was honored four times as a finalist in the category of General Excellence at the National Magazine Awards. While at The American Lawyer, she also spent four years in London as the editor of its European affiliate, Legal Business, which was named Editorial Team of the Year by the U.K. Press Gazette in 1994. Dillon was also named Feature Writer of the Year runner-up by the U.K. Press Gazette in 1993. She is a graduate of Cornell University and Northwestern University's Medill School of Journalism.

#### Henry Dubroff

Dubroff is editor and publisher of the Pacific Coast Business Times. He is the president and majority owner of the newspaper's parent company, Pacific Coast Business Times Inc.,



which he founded in 1999. Among financial journalists, Dubroff is known as one of the nation's leading experts in local business news operations. He was business editor of The Denver Post from 1988 until 1995 and he served as part of a management team that rescued The Denver Post from near bankruptcy in one of the most successful turnarounds in the newspaper industry. From 1995 until 1999 he was editor of The Denver Business Journal, a weekly newspaper that covers business in Colorado's fast-growing economy.

# ONFERENCE SPEAKERS

In April 2001, the Pacific Coast Business Times won a Certificate of Merit in the annual "Best In Business" competition conducted by SABEW. In 1999, Dubroff and his staff at The Denver Business Journal also won the "Best In Business" award in the weekly business journal category. In 1997, The Denver Business Journal was a finalist for the Gerald R. Loeb awards in Business Journalism at UCLA. Dubroff is a past president of SABEW and he co-chaired a successful effort to raise \$1.1 million for an endowed chair in business journalism at the University of Missouri.

#### Sandra Duerr

Duerr has been executive editor of The Tribune in San Luis Obispo, CA since July 1998, leading the staff to win numerous state and national awards for its coverage. She began



her newspaper career in 1975 as a reporter at The Waukesha Freeman, a community newspaper outside Milwaukee, WI. In 1983 she joined The Courier-Journal in Louisville, KY as a business writer. During her 15 year tenure in Louisville, she was business editor and assistant managing editor. She was a John S. Knight Journalism Fellow at Stanford University in 1989-90 and president of SABEW in 1991-92. She was given the Knight Ridder Excellence Award in 2000 for her accomplishments at The Tribune.


#### Mary Flannery

#### Abigail P. Johnson



He also won the John Hancock Award for excellence in business and financial journalism. Sloan is also a contributor to Public Radio International's "Marketplace," whose "Sloan Sessions" are broadcast on Monday mornings, and frequently appears as a commentator on the PBS television program, "Nightly Business Report." He previously received SABEW's distinguished achievement award.

#### Sheila Solomon

Solomon is senior editor for recruitment at the *Chicago Tribune*, where she oversees the newsroom's internship and residency programs and the recruiting and training of newsroom



professionals. Her career spans 28 years, beginning with a reporting internship at the *Hampton* (Va.) *Monitor*. She has held the positions of reporter, copy editor/page designer, interim bureau chief, assigning editor, public editor, trainer and recruiter at newspapers including Newsday, *The Charlotte Observer* and the *Daily Press*. She was the first African-American on the board of directors of the Virginia Press Association and the Virginia Coalition for Open Government.

#### Anne Marie Squeo

In this role, she was part of a small group that won the 2000 Pulitzer for national reporting with a series of stories about remaking the US military for the 21st century. Prior to joining the WSJ, she was at Bloomberg News for nearly 6 years, covering a range of industries, and for her last four years was based in Washington. She provided daily coverage of the landmark case against Microsoft Corporation. Squeo graduated from St. John's University with undergraduate degrees in communications and business and has a master's in journalism.

#### Deborah Turcotte

Turcotte is the business reporter for the Bangor Daily News in Maine, and is a former page designer and copy editor. Within the last year, Turcotte has covered the bankruptcies of Great Northern Paper Inc. and Bangor & Aroostook Railroad, plus the deaths of 14 foreign workers who drowned in a vehicle accident while en route to their job site in Maine's Allagash Wilderness Waterway. She has won numerous Maine Press Association awards in writing and page design, and was the only daily reporter in the state to win two first-place newswriting honors last year. Her resume includes being the first reporter in the world to interview author Stephen King after his life-threatening accident in 1999 and the first to extensively interview the driver who hit King. Turcotte is a graduate of Washington State University, and the mother of two daughters born on different dates in 2000 who wishes she had invested in Procter & Gamble (for Pampers) in 1999.

#### Christian Wihtol

Wihtol is business editor of *The Register-Guard*, (Eugene, Ore). He has been there since 1990 as a business reporter and copy editor. Before joining *The Register-Guard*, Wihtol worked at *The Record*, (Hackensack NJ). He



has an undergraduate degree in English Literature from Oxford University in the United Kingdom and an MBA from Fairleigh Dickinson University in New Jersey.

#### Jack F. Williams

Williams is a Professor at Georgia State University College of Law in Atlanta, GA, where he teaches and conducts research in a number of areas, including Bankruptcy, Business






# Floor Map of the Royal Sonesta Hotel


# Lobby Level East Tower
